**FOUNDATIONS FOR NEW GENERATORS AND PUMPING SYSTEMS -** Upon a motion by Deputy Mayor Christiansen and seconded by Trustee Parisi, it was unanimously,

**RESOLVED** (#2017-11-10), to approve Speedway Concrete as the lowest responsible bidder to install foundations for new generators and pumping systems for the Water Department at a cost of \$25,882.

**OVERSIGHT OF UPGRADE OF GENERATOR AND BOOSTER -** Upon a motion made by Trustee Parisi and seconded by Trustee Priestley, it was unanimously,

**RESOLVED** (#2017-11-11), to hire James Woerner at the rate of \$150 per hour or \$1,200 per day for oversight of the upgrade of the generator and booster.

**BEAUTIFICATION** – Deputy Mayor Christiansen reported that mum plants are doing well and she thanked the DPW Staff for watering and maintaining the plants.

Main Street/Melville Road triangle will be decorated on Monday, November 28<sup>th</sup> along with trees at the Gazebo, ornaments in the fountain and Gerngras Park. All decorating will be completed for the Holiday Tree Lighting on November 29<sup>th</sup>.

A sign enlisting the help of volunteers has been put up in Village Green, notice has been placed in the Farmingdale Observer, Facebook and the Village's website. Many volunteers will be needed.
