CHAPTER 255

BUSINESS IMPROVEMENT DISTRICTS

Article I – General Provisions.

§ 255-1 Authorization and application.

The Board of Trustees finds that Business Improvement Districts (BIDs) provide significant benefits to residents near BIDs and the public at large. In furtherance thereof, the Board of Trustees hereby authorizes the application of General Municipal Law, Article 19-A, Business Improvement Districts, to and within the Incorporated Village of Farmingdale.

§ 255-2 Referendum. Effective date.

The authorization and application pursuant to §255-1 is subject to a permissive referendum and shall not become effective until 30 days have elapsed since its adoption provided no petition objecting to §255-1 has been filed with the Incorporated Village of Farmingdale. If such petition is filed within such 30 days, §255-1 shall not become unless the permissive referendum mandates set forth in Article 9 of the Village Law have been satisfied.
